

# Availability of Market Conduct Enforcement Actions<sup>1</sup>

## Life & Health

Access to market conduct enforcement content is critical in assessing your noncompliance risks or preparing for an examination. The states vary in their approach to offering this information. To date, only 31 offer access to the enforcement actions online, and even fewer, 16, offer it in a way that it can be easily used. The Market Conduct Module for NILS INsource is the only source offering complete and searchable content for available market conduct enforcement activities.

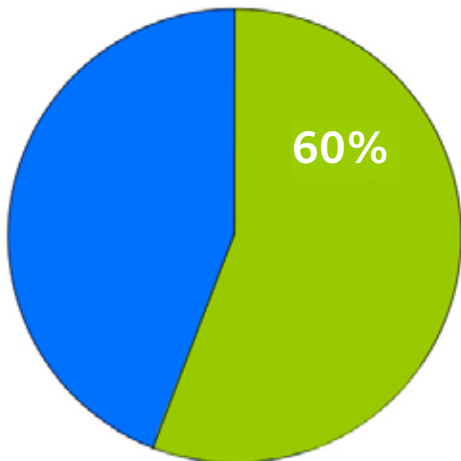

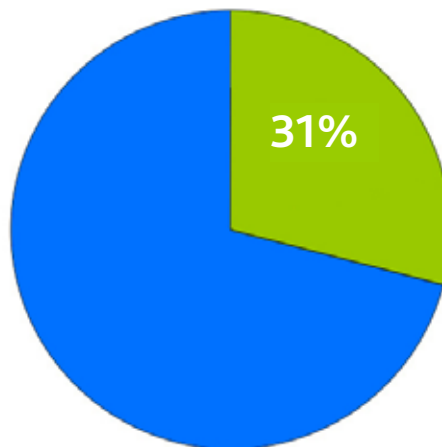

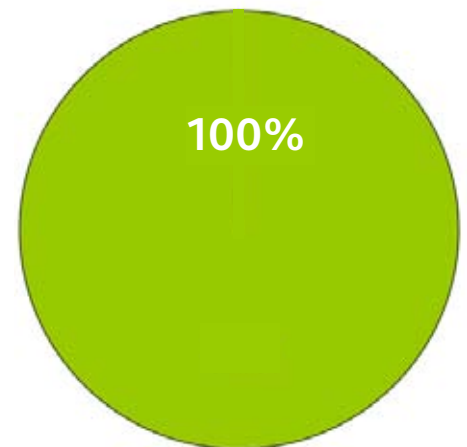
